#### Summary

The Deliverable E1.D16 “1<sup>st</sup> LIFE-IP CEI Greece Conference Proceedings” compiles a synopsis of the presentations of the Inaugurating conference of LIFE-IP CEI-Greece that took place on-line on January, 21 2021. The 1<sup>st</sup> conference of LIFE-IP CEI-Greece addressed all stakeholders that are involved in the transition of Greece towards a Circular Economy and was completed with great success.

The topics of the conference included presentations of the LIFE-IP CEI-Greece demonstration actions in 9 municipalities and 1 region, in order to promote: the implementation of waste hierarchy, actions on food waste prevention and circular management of agro-food waste, actions for the establishment of standards for secondary materials, an electronic repository for the exchange of knowledge, a national observatory for Circular Economy and finally, actions for the development of economic and financial instruments as well as capacity building.
